

Privacy Policy

What type of information do we collect?

We receive, collect and store any information you enter on our website or provide us in any other way.

We collect your name, email address, billing details if you purchase a product from us, your Internet Protocol (IP) address and means of searching e.g. desktop or mobile device.

How do we collect information?

When you complete a transaction on our website, as part of the process, we collect personal information you give us such as your name, address and email address. When you subscribe to our newsletter we store your name and email address. When you message us directly through a contact us form. Your personal information will be used for the specific reasons stated above only.

Why do you collect such personal information?

1. We collect your personal information for marketing campaigns and newsletters.
2. We collect your address information to verify bank transactions and purchases made on the site.
3. To create statistical data to improve our services
4. To comply with any laws and regulations.

How do we store, use, share and disclose your personal information?

Your personal information will be downloaded as a report and printed for the use of sign off sheets at a specific event. This information will then be deleted from the PC and paper copies shredded beyond the use of the specific event.

Our company is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our products and services to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

All direct payment gateways offered by Wix.com and used by our company adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.

How we communicate with our site visitors?
